## Hill Wilson Appointed to 2008 Philadelphia Bar Association Brennan Award Committee

The Philadelphia Bar Association's prestigious William J. Brennan, Jr. Distinguished Jurist Award, recognizes a jurist who adheres to the highest ideals of judicial service. Any member of the state or federal bench, whether active or retired, who has made a significant, positive impact on the quality or administration of justice in Philadelphia is eligible for consideration. Examples of accomplishments worthy of nomination include innovations in court administration, implementation of pioneering case management techniques, assumption of a leadership role in areas affecting the administration of justice, publication of a significant opinion, article, or other scholarly work, or the like.

Notable past award recipients include the Award's namesake, U.S. Supreme Court Justice William J. Brennan, Jr., who was the first recipient of the award in 1995. Others include: President Judge Alex Bonavita of the Philadelphia County Court of Common Pleas (1996), Judge Phyllis W. Beck of the Pennsylvania Superior Court (1997), Chief Judge Edward R. Becker of the U.S. Court of Appeals for the Third Circuit (1998), Judge Louis C. Bechtel of the U.S. District Court for the Eastern District of Pennsylvania (1999), Chief Judge James T. Giles of the U.S. District Court for the Eastern District of Pennsylvania (2000), and Justice Russell M. Nigro of the Pennsylvania Supreme Court (2002).
